- 學分數至少130學分：
The number of credits must be at least 130 credits.
(1) 校訂必修課程29學分，其中包含：
(1) University-specific required courses account for 29 credits and include:
A. 基礎通識(國文4學分、多元教學應用2學分、英文6學分、體育4學分)。
A. Basic general education courses sixteen credits (4 credits in Chinese literature, 2 credits in Multiple Narrative Application, 6 credits in English, and 4 credits in Physical Education).
B. 核心通識(生涯規劃與發展2學分、環境服務教育與實習1學分)。
B. Core general education courses three credits (2 credits in Career Planning and Development and one credit in Environmental Service Education and Practice).
C. 選修通識課程(人文藝術、社會科學、自然科學與前置課程) 每類選修2-4學分，合計10學分。
C. Elective general education courses (2-4 credits each from Humanities and Arts, Social Sciences, Natural Sciences, and Creative Interdisciplinary categories, for a total of 10 credits).
(2) 學分必修課程14學分，系訂專系必修課程40學分。
(2) A total of 14 credits in college-specific required courses, along with 40 credits in department-specific professional required courses.
(3) 專業選修課程至少47學分，其中系訂專系選修課程至少二分之一學分須修習本系開設之課程(含學院選修課程)。完成修習本校跨領域學分學程者，他系修讀學分則計於專系選修學分方式，應依據「政理科技大學跨領域課程設置辦法」辦理。
(3) At least 47 credits of professional elective courses, of which at least one-half of the credits of departmental professional elective courses must be earned from courses offered by the department (including college elective courses). For those who have completed the interdisciplinary credit program of the University, the credits from other departments will be counted as professional elective credits in accordance with the "Regulations for the Establishment of Interdisciplinary Programs of Chihlee University of Technology".
(4) 每學期修業學分數：第1-2學年16-25學分，第3學年12-25學分，第4學年9-25學分。
(4) Credits per semester: 16-25 credits in the first and second academic years, 12-25 credits in the third year, and 9-25 credits in the fourth year.
(5) 請勿重複修習已修習過之課程或未經核准上修本系課程，否則該課程不予認列為畢業學分數。
(5) Please refrain from retaking courses previously completed or enrolling in advanced departmental courses without approval. Credits earned from such courses will not be counted toward graduation requirements.
(6) 本系學生於畢業前，必須符合下列系訂專系畢業門檻規定：
Students in the department must meet the following graduation threshold specifications prior to graduation.
(1) 通過校訂專系訂專系英語能力檢定。
(1) Pass the university-specific and department-specific English proficiency test.
(2) 通過系訂專業能力檢定。
(2) Pass the department-specific professional competency test.
(3) 通過系訂資訊能力檢定。
(3) Pass the department-specific information competency test.
(4) 通過校訂「學術倫理教育」課程。
(4) Complete the University-mandated "Academic Ethics Education" program.
(5) 修業條件請完成其中一項畢業資格：
(5) Completion of one of these courses is required for graduation:
a. 任一跨領域學分學程
a. Any one interdisciplinary credit program
b. 一個本系課程模塊及一個微課程
b. One module of the department's curriculum and one micro-program
c. 一個輔系
c. One minor
d. 一個雙主修
d. One double major
若未通過者不具畢業資格。
Failure to complete the requirement will result in ineligibility for graduation.
(6) 第二外語課程至少修習一門2學分，語言類得認列選修學分上限為6學分。
(6) At least one 2-credit course in a second foreign language, with a maximum of 6 credits of recognized elective credits in the language category.
(7) 通過「校外實習」課程，相關規定請參閱本系課程目錄表頁碼第57頁。
(7) Pass the "Off-Campus Internship" course, as detailed in the guidelines in Note 5 of the course list.
(8) 本系學生修習實習相關課程至少3學分。
(8) Students in this department are expected to take at least 3 credits of internship-related courses.
(9) 學生可修習本系開設之「國際商務綜合實習(A-D)」、「國際商務綜合實習(暑)」、「職場實習(一)-(二)」等任一課程，完成實習規定時數並取得成績，得申請通過「校外實習」課程。
(9) Students may take any of the courses offered by the department, such as "Integrated International Business Internship A-D", "Integrated International Business Internship (Summer)", or "Workplace Internship (I)-(II)", and complete the required number of hours of the internship and receive a grade.
(10) 實習課程學分得認列選修學分上限為9學分。
(10) The maximum number of credits that can be recognized as elective credits for internship courses is 9 credits.
(11) 具有身心障礙手冊之學生、陸生、外籍生及備生得申請免修本系定「校外實習」課程。
(11) Students with disabilities, students from mainland China, foreign students, and overseas Chinese students may apply for exemption from the mandatory off-campus internship course in the department.
(12) 本系學生在學期間應完成專題製作，並參與本系專題競賽及校外專題競賽至少1次。
(12) Students in the department should complete the Special Project and participate in at least one departmental project competition and one off-campus project competition during their studies.
(13) 本系學生在學期間應修讀本系開設「國際商務實習(一)」及「國際商務實習(二)」之課程，並全程參與國際貿易展覽相關競賽。
(13) During the period of study, students must complete and pass the department's courses "International Trade Show Practice I" and "International Trade Show Practice II" and fully participate in related international trade exhibition competitions.
(14) 畢業生應符合國內高級中等學校二年級之學業或同等、澳門同級同類學校畢業生，以同等學力資格入學本系四年級一年級者，除須符合本系規定之畢業總學分數修讀規格外，應另增加畢業選修學分數12學分。
(14) Graduates equivalent to the second year of senior high school in Taiwan or from schools of similar levels in foreign countries, Hong Kong, or Macau who enroll in the first year of the four-year program of the department under the qualification of equivalent academic competence must fulfill the total credit requirement set by the department. In addition, they must complete an additional 12 credits for graduation.
(15) 學生修習本校認可之選修課程，依本校選修課程學分抵免要點與選修課程學分實施要點辦理。
(15) Credits earned from massive open online courses (MOOCs) offered or recognized by CLUT may be counted toward graduation requirements as per the CLUT guidelines for the implementation and transfer of credits from these courses.
(16) 本應修科目表學分分為括弧()者，則表示該學分不計入畢業學分數。
(16) Credits in parentheses in the course requirement table are not counted toward the total graduation credits.
(17) 本應修科目表因應本系特色發展之需要時，得依據本校課程規劃流程修正。
(17) According to the developmental needs of the department, the course requirement table may be revised by adhering to the University's course planning procedures.
